4. First aid measures

Eye contact

6. Accidental release measures

Personal precautions

: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Methods for cleaning up

7. Handling and storage

Handling

Recommended monitoring procedures


